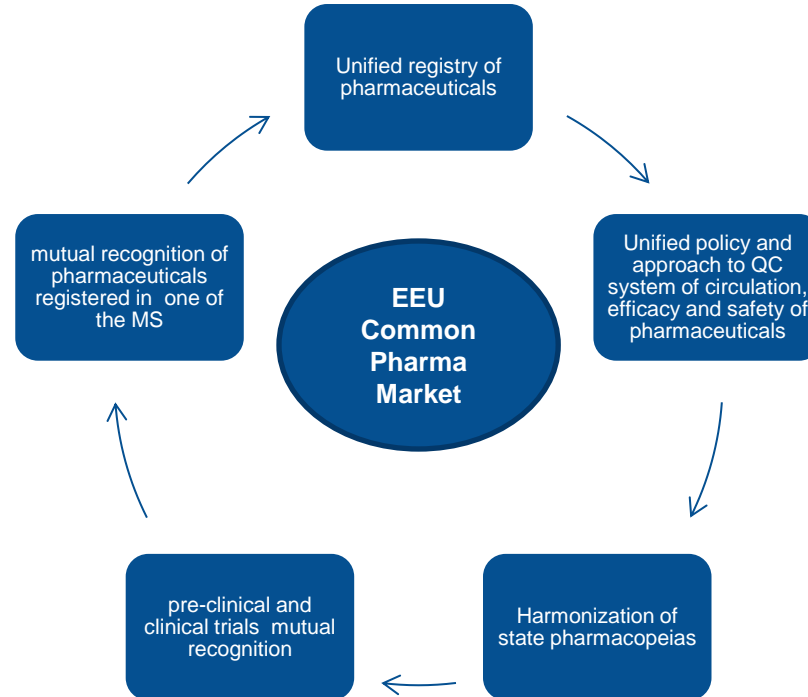

EAEU: common market of pharmaceuticals(2/3)

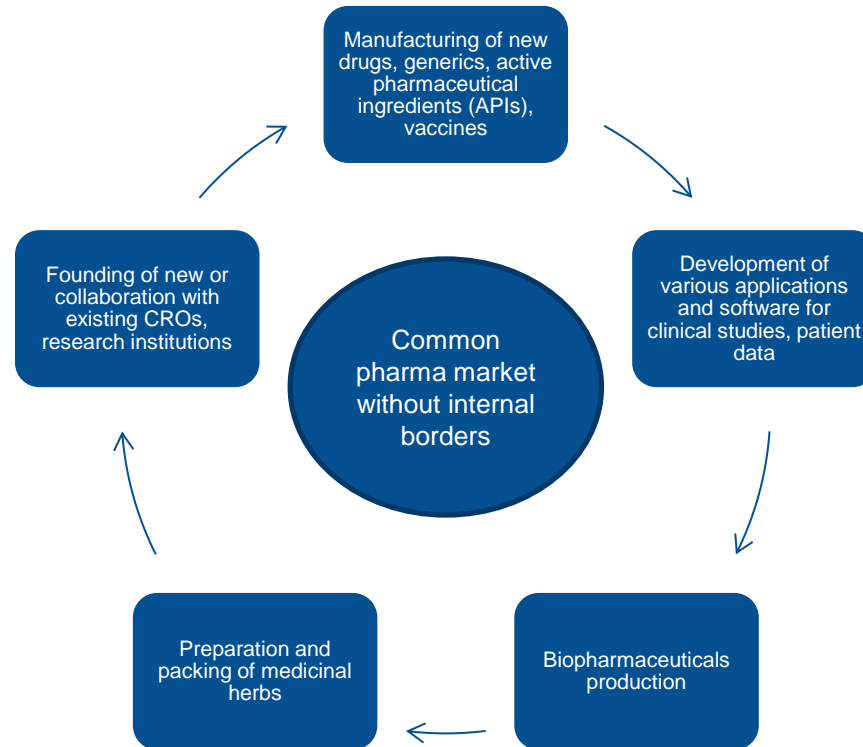

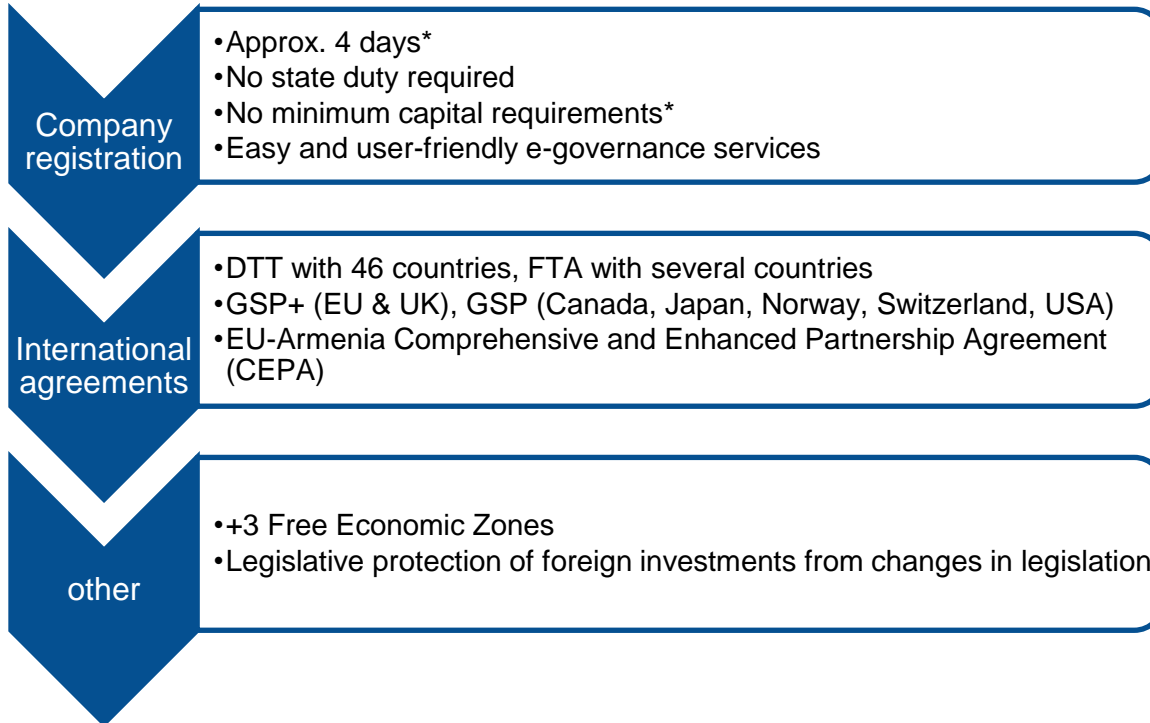

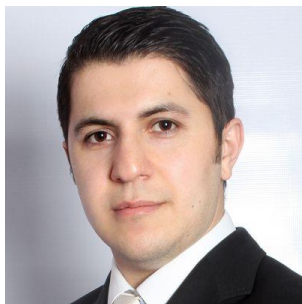
