IT Startup

- 0% tax on outsourcing services
- 10% tax on salary
- 16,000 IT specialists
- Market needs 40,000

Income Tax

- 23-36% on salary (depending on volume)
- From July 1 all 23% all
- From January 1, 2020 - 22% all
- From 2021 - 21% all
- From 2022 - 20.5% all
- From 2023 – 20% all

Other taxes

- Dividend tax from 10% to 5% for non residents
- July 1, 2019 – Taxes on Tobacco and Alcohol 
- January 1, 2020- Taxes on gambling and lottery 
- Pension tax from 2019 July 1:
2,5%(ind) – 7,5%(gov)  5%(ind) – 5%(gov)

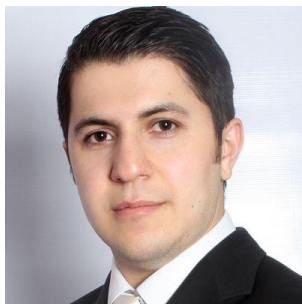
